No.: <u>GujRERA.2018/Gen. Reg./Amdt 4</u>. In exercise of the power conferred on it under subsection (1) and sub-section (2) of section 85 of the Real Estate (Regulation and Development) Act, 2016 and all other powers enabling in that behalf the Gujarat Real Estate Regulatory Authority hereby amends the Gujarat Real Estate Regulatory Authority (General) Regulations, 2017 as follows namely: -

1. Short title and Commencement. -

- (1) These Regulations may be called the Gujarat Real Estate Regulatory Authority (General) (Second Amendment) Regulations, 2018.
- (2) It shall come into force at once.
- 2. Substitution of Form 5 of the Gujarat Real Estate Regulatory Authority (General) Regulations, 2017. For Form 5 of the Gujarat Real Estate Regulatory Authority (General) Regulations, 2017, the following new Form 5 shall be substituted, namely: -
